

## Terms and Conditions

1. The Promoter is Carnival plc trading as Cunard whose registered office is at Carnival House, 100 Harbour Parade, Southampton, SO15 1ST.
2. The prize draw is open from 1st November 2017 to midnight on the 12th November 2017.
